**JOINT PROPOSED
EVIDENTIARY HEARING
STRUCTURE**

Pursuant to the Court's Order (Doc. 62), Plaintiff, the Federal Trade Commission ("FTC"), and Defendants Michael Rando, Valerie Rando, Prosperity Training Technology LLC, Digital Business Scaling LLC, First Coast Matchmakers Inc., First Coast Matchmakers LLC, and Financial Consulting Management Group LLC (collectively, "Defendants") propose the following Preliminary Injunction Evidentiary Hearing ("Hearing") structure:

1. **Witness and Exhibit Disclosure** – The parties shall file a list of each witness they plan to call, the substance of the testimony those witnesses are expected to offer, and the exhibits the parties intend to introduce during the Hearing. The Witness and Exhibit Disclosure is to be filed two weeks before the Hearing.

2. **Hold Evidentiary Hearing** – The parties propose that the Court set aside 4 days for the Hearing, with the understanding that each side have up to 2 days to present its case.

3. **Proposed Schedule** – The parties propose the following schedule, subject to the Court’s availability:
- a. Witness and Exhibit Disclosure due two weeks before the Hearing.
 - b. Subject to the Court’s availability, Hearing held during the week of August 22, 2022. The parties also propose an alternate week of September 19, 2022, for the Hearing.
