**RECEIVER'S UNOPPOSED SIXTH AND FINAL APPLICATION FOR
ORDER AWARDING FEES, COSTS, AND REIMBURSEMENT OF
COSTS TO RECEIVER AND HER PROFESSIONALS**

Maria M. Yip, the Court-appointed Receiver (the "Receiver") over the
corporate Defendants (the "Receivership Entities"¹), the Court's Orders dated

January 10, 2023 (Docs. 116 and 117) (the “Appointment Order”), respectfully submits this Sixth Fee Application to the Court for the entry of an order allowing the Receiver to pay fees and the reimbursement of costs to the Receiver and her professionals from the funds previously held back. This is the last fee application from the Receiver and covers all fees and costs incurred from September 1, 2024, through the conclusion of the Receivership.

I. Procedural Posture.

On October 3, 2024, the Receiver requested the Court’s approval to turn over to the FTC the funds she had marshalled for the benefit of the consumers affected by the Defendants as well as to close the Receivership. (Doc. 146)(“Motion to Close”) The Court granted the motion on October 16, 2024. (Doc. 148)(“the Order”) Within a week of the Court’s Order, the Receiver transferred the funds to the FTC for them to handle the consumer redress process. Payments were sent out by the FTC to affected consumers in June 2025. *See* attached Exhibit 1.

Pursuant to the Receiver’s Motion to Close and the Court’s Order granting that motion, the Receiver set aside \$30,000 from the estate for the payment of any potential tax liabilities. Yip Associates completed the final tax returns for the Receivership and it was determined that the Receivership Estate owes no federal taxes.

In the Motion to Close, the Receiver had estimated professional fees and

expenses for the winding down of the Receivership to be \$20,000. The Court's Order did not require the Receiver to submit her final invoices before payment, only to submit a Closing Declaration.

However, the actual amount of professional fees, particularly for the completion of the tax returns, was significantly higher than the Receiver's estimate. For example, there were unforeseen issues related to the analysis of the tax basis for certain Receivership assets. Additionally, the timeline for the FTC to make payments to the consumers was longer than anticipated by the Receiver and thus resulted in higher expenses (i.e. website and electronic data storage) and fees related to the Receiver's responses to the FTC's Receivership Asset Surveys. Since September 1, 2024, the Receivership Estate has incurred the following fees and expenses:

- a. Receiver Maria Yip - \$5,671.25 in fees and \$1,520.00 in costs, for a total of \$7,191.25 (Exhibit 2);
- b. Receiver Maria Yip - Operational Expenses \$3,371.65 (Exhibit 3);
- c. Yip Associates - \$29,705 in fees and \$720.69 in expenses, for a total of \$30,425.69 (Exhibit 4);
- d. Johnson, Newlon & DeCort - \$4,608.00 (Exhibit 5); and
- e. E-Hounds - \$2,688.50 (Exhibit 6),

for a total of \$48,285.09. The fees listed above include hours billed through October 31, 2025, plus an additional two hours each of billable time for the Receiver, Danny Zamorano of Yip Associates and Katherine Donlon of Johnson, Newlon & DeCort to complete all tasks to wind down the Receivership.

Given the reasonable amount of fees and expenses, the extended length of time it took for the distribution to be made to consumers, and the fact that the tax reserve of \$30,000 was not used or necessary, the Receiver requests that the Court approve the Receiver's request to make these final payments from the \$50,000 currently reserved by the Receiver. Any monies not used from that reserve will be turned over to the FTC as required by the Court's Order.

Counsel for the Receiver discussed this issue with counsel for the FTC and they had no objection to using the tax reserve for the payment of these professional fees and expenses.

II. The Receiver.

The Receiver requests the Court award her fees for the professional services rendered and costs incurred from September 1, 2024, through the conclusion of the Receivership, in the amount of \$5,671.25 and \$1,520.00, respectively. In addition, the Receiver advanced Operation Costs for the

Receivership Entities in the amount of \$3,371.64. A copy of the statement summarizing the Receiver's services rendered for the Receivership is attached as Exhibit 2. The Receiver's time and fees for services rendered from September 1, 2024, through the conclusion of the Receivership, are 23.3 hours at \$325/hour.

In addition to her professional fees, the Receiver had costs of \$1,520.00 (including services through the conclusion of the Receivership) as summarized below:

In addition to these out-of-pocket costs, the Receiver had advanced certain Operational Costs for the Receivership Entities. These Operational Costs (including costs through the conclusion of the Receivership) are specifically listed on Exhibit 3 and total \$3,371.65.

III. Yip Associates.

The Receiver requests the Court award Yip Associates fees for professional services rendered from September 1, 2024, through the conclusion of the Receivership, in the amount of \$29,705.00. Travel time was billed at 50% discount. Yip Associates has completed its forensic accounting work for the Receiver. A copy of the statement summarizing the services rendered and expenses for the pertinent period, including a summary of the professionals' hours, is attached as Exhibit 4.

IV. Johnson Newlon & DeCort (“JND”).

The Receiver requests the Court award JND fees for professional services rendered from September 1, 2024 through the conclusion of the Receivership. A copy of the statement summarizing the services rendered by JND from September 1, 2024 through the conclusion of the Receivership, is attached as Exhibit 5. JND’s time and fees for services rendered on this matter for each professional are as follows:

V. E-Hounds, Inc.

Over the life of this Receivership, E-Hounds has provided the online platform for all of the electronic records involved in this matter. The Receiver requests that the Court approve E-Hounds’ fees for services rendered and costs incurred from September 1, 2024 through October 31, 2025, in the amount of \$2,688.50. Copies of the E-Hounds statements summarizing the platform charges are attached as composite Exhibit 6.

MEMORANDUM OF LAW

It is well settled that this Court has the power to appoint a receiver and to award the receiver and those appointed by her fees and costs for their services. *See, e.g., S.E.C. v. Elliott*, 953 F.2d 1560 (11th Cir. 1992) (receiver is entitled to compensation for faithful performance of his duties); *Donovan v. Robbins*, 588 F. Supp. 1268, 1272 (N.D. Ill. 1984) (“[T]he receiver diligently and successfully discharged the responsibilities placed upon him by the Court and is entitled to reasonable compensation for his efforts.”); *S.E.C. v. Custable*, 1995 WL 117935 (N.D. Ill. Mar. 15, 1995) (receiver is entitled to fees where work was of high quality and fees were reasonable); *S.E.C. v. Mobley*, 1317RCC, 2000 WL 1702024 (S.D.N.Y. Nov. 13, 2000) (court awarded reasonable fees for the receiver and his professionals); *see also* Doc. 11 ¶ 16. The determination of fees to be awarded is largely within the discretion of the trial court. *See Monaghan v. Hill*, 140 F.2d 31, 34 (9th Cir. 1944). In determining reasonable compensation for the services rendered by the

Receiver and her Professionals, the Court should consider the circumstances surrounding the Receivership. *See Elliot*, 953 F.2d at 1577.

In determining the reasonableness of fees, the Court must calculate the lodestar, which is the “number of hours reasonably expended on the litigation multiplied by a reasonable hourly rate.” *Hensley v. Eckerhart*, 461 U.S. 424, 433 (1983). This is in part based on the nature and extent of the services rendered and the value of those services. *See Grant v. George Schumann Tire & Battery Co.*, 908 F.2d 874, 877-78 (11th Cir. 1990) (bankruptcy fee award case addressing the issue of attorney’s fees generally before considering specific requirements in the bankruptcy context). Additionally, the Court should consider the twelve factors set forth in *Johnson v. Georgia Highway Express, Inc.*, 488 F.2d 714 (5th Cir. 1974), a case involving an award of attorneys’ fees under federal civil rights statutes, as incorporated by the Eleventh Circuit in *Grant*, a bankruptcy case, are as follows: (1) the time and labor required; (2) the novelty and difficulty of the questions presented; (3) the skill required to perform the legal services properly; (4) the preclusion of other employment by the attorney due to acceptance of the case; (5) the customary fee for similar work in the community; (6) whether the fee is fixed or contingent; (7) time limitations imposed by the client or by the circumstances; (8) the amount involved and results obtained; (9) the experience, reputation, and ability of the attorney; (10) the undesirability of the case; (11) the nature

and length of the professional relationship with the client; and (12) awards in similar cases. Based on the information provided herein as well as the Receiver's periodic status reports, the Receiver believes that the Court when considering these factors and the work accomplished during this quarter of the Receivership will determine that the Receiver's motion for fees is reasonable and should be granted.

Here, because of the nature of this case, it is necessary for the Receiver to employ attorneys and accountants experienced and familiar with financial frauds, federal Receiverships, banking, and finance. Further, to perform the services required and achieve the results obtained to date, the skills and experience of the Receiver and the Professionals in the areas of fraud, computer and accounting forensics, and financial transactions are indispensable.

As discussed above, the Receiver and JND have discounted their normal and customary rates as an accommodation to the Receivership and to conserve Receivership assets. The rates charged by the Receiver and the Professionals are at or below those charged by similar professionals in the Middle District of Florida. The attached Exhibits detail the time, nature, and extent of the professional services rendered by the Receiver and her Professionals for the benefit of consumers, creditors, and other interested parties. While the Receiver's estimate regarding fees and costs was lower than the requested

amount, she believes the fees and costs expended to wind down and close out the Receivership were reasonable and necessary.

Notably, the FTC has no objection to the relief sought in this motion. *S.E.C. v. Byers*, 590 F. Supp. 2d 637 (S.D.N.Y. 2008) (quoting *S.E.C. v. Fifth Ave. Coach Lines, Inc.*, 364 F.Supp. 1220, 1222 (S.D.N.Y.1973) (“[I]n a securities Receivership, ‘[o]pposition or acquiescence by the SEC to the fee application will be given great weight.”)). Although the cited case relates to an SEC action, a similar argument would be made as it relates to the regulator at issue in this case, the FTC.

CONCLUSION

Under the Court’s Order on the Motion to Close, the Receiver was not required to submit her final invoices to the Court. However, given that the Receiver’s estimate for fees was considerably lower than the actual fees incurred, the Receiver requests that the Court approve the fees described above from the reserves previously set aside by the Receiver for any potential tax liability. In exercising her duties, the Receiver has determined that the services rendered and their attendant fees and costs were reasonable, necessary, advisable, and in the best interests of the Receivership. A summary of those fees, costs and advanced expenses, as well as those fees previously deferred by the Court, is set forth below.

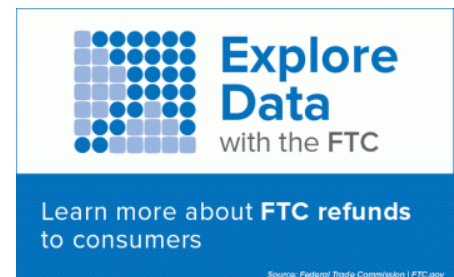

The Federal Trade Commission is sending more than \$3.5 million in refunds to consumers harmed by a credit-repair scheme called 'The Credit Game.'

In 2022, [the FTC sued](#) the scheme's operators, Michael and Valerie Rando, and their companies, alleging that their operation illegally charged consumers hundreds and even thousands of dollars for credit-repair services that provided little to no value.



The FTC's complaint alleged that the defendants:

- Lied to consumers about the legality and effectiveness of their products, and whether consumers would receive a refund when requested.
- Provided false information to credit-reporting agencies regarding consumers' credit reports.
- Harmed consumers by pitching their customers a supposed business opportunity to create their own bogus credit-repair scheme; and
- Encouraged consumers to pay for the bogus services using COVID-19 tax relief funds, in violation of the COVID-19 Consumer Protection Act.

The FTC's action resulted in an order halting the company's illegal operations and [banning](#) Michael and Valerie Rando from the credit-repair industry. The order also required them to turn over assets to provide refunds to consumers harmed by the scam.

The FTC is sending checks and PayPal payments to 9,224 affected consumers. Check recipients should cash their checks within 90 days, as indicated on the check. PayPal recipients should redeem their PayPal payments within 30 days.

Consumers who have questions about their payment should contact the refund administrator, Simpluris, at 833-296-0723, or visit the FTC website to [view frequently asked questions](#) about the refund process. The Commission never requires people to pay money or provide account information to get a refund.

The Commission's [interactive dashboards for refund data](#) provide a state-by-state breakdown of refunds in FTC cases. In 2024, FTC actions led to more than \$339 million in refunds to consumers across the country.
